### SECTION 4 - FIRST AID MEASURES

**General advice:** First Aid responders should pay attention to self-protection and use the recommended protective clothing (chemical resistant gloves, splash protection). If potential for exposure exists refer to Section 8 for specific personal protective equipment.

## SECTION 5 - FIRE FIGHTING MEASURES

**Suitable Extinguishing Media:** Dry chemical, foam, carbon dioxide or fog is recommended. Water spray is recommended to cool or protect exposed materials or structures. Carbon dioxide can displace oxygen. Use caution when applying carbon dioxide in confined spaces. Simultaneous use of foam and water on the same surface is to be avoided as water destroys the foam. ## SECTION 6 - ACCIDENTAL RELEASE MEASURES

**Emergency Procedure:** ELIMINATE all ignition sources (no smoking, flares, sparks or flames in immediate area). RELEASE CAN CAUSE FIRE/EXPLOSION. LIQUIDS/VAPORS MAY IGNITE.

Do not touch or walk through spilled material.

Isolate hazard area and keep unnecessary people away. Remove all possible sources of ignition in the surrounding area. Notify authorities if any exposure to the general public or the environment occurs or is likely to occur.

## SECTION 7 - HANDLING AND STORAGE
