SECTION 4 - FIRST AID MEASURES

Inhalation: Remove source of exposure or move person to fresh air and keep comfortable for breathing. If victim is not breathing, call 911 and administer CPR as directed.

SECTION 5 - FIRE FIGHTING MEASURES

Suitable Extinguishing Media: Dry chemical, foam, carbon dioxide or fog is recommended. Water spray is recommended to cool or protect exposed materials or structures. SECTION 6 - ACCIDENTAL RELEASE MEASURES

Do not touch or walk through spilled material.
